

Official Rules for Techthelead iPhone X Giveaway
No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- 1. Eligibility: Techthelead iPhone X Giveaway** (the “Giveaway”) is open to anyone (Domestic or International), who is at least eighteen (18) years of age, who has internet access and a valid email address. Employees, independent contractors, interns, officers, directors, and agents of Sponsor, other companies associated with the Giveaway, as well as the immediate family members (spouse, parents, siblings, and children, and their respective spouses) and household members of any of the foregoing are not eligible to enter. **VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

- 3. Administrator:** Survey Monkey. (“Administrator”).
- 4. Agreement to Official Rules:** By entering the Giveaway, you indicate your full and unconditional agreement to, and acceptance of, (a) these Official Rules and (b) Sponsor’s decisions, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 5. Entry Period:** The Giveaway begins at 7:00 PM EEST on Friday, May 18, 2018 and ends at 7:00 PM EEST on Friday, June 8, 2018, (the “Entry Period”). Entries submitted before or after the Entry Period will not be eligible. Administrator’s computer is the official time-keeping device for the Giveaway. Entries submitted before or after the applicable Entry Period will not be eligible.
- 6. How to Enter:** During the Entry Period, visit <http://techthelead.com/giveaway-iphone-x/> (the “Giveaway Website”), and enter the official survey form by answering the questions prompted and filling out your name and email address in the fields indicated, as well as by completing the mandatory actions detailed on the Giveaway Website. You will receive one (1) entry for completing the following action directly from the links on the Giveaway Website: answering to Techthelead’s official survey questions (the “Entry”). There is a limit of one (1) Entry per person during the Entry Period. Entries in excess of the allowable limit will not be acknowledged. The use of an agency or any automated system to enter is strictly prohibited and Sponsor reserves the right to disqualify any entries received through such methods, as determined by Sponsor, in its sole discretion.
- 7. Drawing:** After the Entry Period, Sponsor will select one (1) winner in a random drawing of all entries received.
- 8. Notification and Requirements of Potential Winner:** Potential winner will be contacted by email to the email account used to enter the Giveaway within the day of the drawing. Failure to respond to the initial verification notice within twenty-four (24) hours after notification or return of verification notice as undeliverable after three (3) attempts will result in disqualification; if a potential winner is disqualified, the Sponsor will select an alternate potential winner in his/her place at random from all remaining entries received. Only three (3) alternate potential winners will be contacted. Except where prohibited, a potential winner

may be required to complete and return an affidavit of eligibility and liability/publicity release.

Prize:** The winner will receive one (1) iPhone X, 64 GB, Silver smartphone with an ARV of 5199 lei (\$1,122 at the current exchange rate via European Central Bank). **Winner is responsible for paying any applicable income taxes and any and all other costs and expenses not listed above.** Any Prize details not specified above will be determined by Sponsor in its sole discretion. The Prize will be delivered to Winner at the address designated by Winner. The Prize may be subject to additional terms and conditions. The Prize (or any Item) may not be transferred and must be accepted as awarded. You may not request cash or a substitute prize; however, Sponsor reserves the right to substitute Prize (or one or more Item) with another prize of equal or greater value if the Prize (or one or more Item) is not available for any reason, as determined by Sponsor in its sole discretion.

The “authorized account holder” is the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted e-mail address.
